### 2009-2010 Farmers' Market Civic Group Information

#### **Fees**

- Fees allow us to pay for market insurance, grounds maintenance, market management, printing costs, events at the markets and publicity.

#### **Market Standards & Application Process for Civic Groups**

Farm Fresh Rhode Island strives to foster markets that are inclusive and respectful to the communities that host them and to the diverse patrons who come to the markets. Our markets offer a bounty of locally grown and produced foods that are unrivaled in quality and freshness.

- **The markets emphasize the farmers and the food, and so there is a maximum of 2 civic groups per market day.** Space varies across locations and so there may be room for only 1 or no non-food at a given market on a given day.
- **An application to attend a market(s) must be received 5 days in advance of the market(s).** Applications can be sent via postal mail or e-mail. A Farm Fresh staff member will promptly follow up with the civic group about the request.
- **Farm Fresh RI reserves the right to decline an application.** Consideration will be given to how the civic group relates to our mission and our goals for a given market and the relationship of the civic group to the neighborhood and community of the market. Your organization must be based in Rhode Island and its mission must focus on food, the environment, cities or public spaces.
- **Civic groups are expected to provide their own equipment. A table is required, and we prefer a tent as well.** Few markets have electricity or bathrooms. Some markets also require attendees to drop off their booth materials and then park in an area away from the market. The market manager will determine the location of a civic group at the market.
- **The needs of our farm and food vendors take precedence over the needs of civic groups at all times.** Farm Fresh RI can approve an application for a table but not for sales, if it may interfere with vendor sales. This could result, for example, in a civic group being asked to change locations from one week to the next.
- **Market fees should be paid by check to "Farm Fresh RI" prior to or on the first day of market attendance.** Payment cannot be refunded, though a group that does not attend on a day that is already paid for will receive a credit toward a future day.
- **Civic groups can:**
  - Set up a table display and hand out literature
  - Sell items related to the group's mission and that do not interfere with other vendors (must provide RI Sales Tax Permit)
- **Civic groups can not:**
  - Solicit aggressively: no cornering customers, no shouting, no following customers beyond your table
  - Sell food

Failure to comply with these standards degrades the market and will jeopardize participation.
